Convention on the Rights of the Child


Adopted and opened for signature, ratification and accession by General Assembly resolution 44/25 of 20 November 1989

entry into force 2 September 1990, in accordance with article 49

Convinced that the family, as the fundamental group of society and the natural environment for the growth and well-being of all its members and particularly children, should be afforded the necessary protection and assistance so that it can fully assume its responsibilities within the community,


Defining Parenting Programs

- Interventions or services designed to support parental care interactions, behaviors, knowledge, beliefs, attitudes and practices.
- Promote positive or nurturing parenting.
- Introduce parenting methods with regards to early development, functions, provision of care.
- Could cover health, nutrition, stimulation and protection.



- 108 parenting programs across the Arab region
- ❖ 32 programs in the Arabian Gulf
- ❖ 38 programs in the Arab Mashreq
- 26 programs in the Arab Maghreb
- 12 programs in less developed countries



Parental Education

- 34 programs
- Knowledge transfer, awareness of characteristics of childhood, parental care in the social, religious and medical contexts etc...

Parental Support

- 29 programs
- Psychological support, family relations, care, and services, family stability, relations, social care, support for families with special needs

Parental Training

- 27 programs
- Parental integration, care mechanisms and methods, upbringing, involvement of children, reproductive health

Parental Interventions


- 18 programs

Recommendations

Families:

- Providing support for at-risk families,
- Anger management training in dealing with children,
- Raising parents' awareness on positive parenting
- Conflict resolution among divorced ex-spouses, and
- Training on behavior modification techniques.

Child:

- Supporting children's psychosocial needs
- Empowering children with learning disabilities,
- Focusing on child safety during parental conflicts, child rights, and child protection.

Recommendations

Society:

- Forming networks and coordination between governmental, non-governmental and international organizations on parenting issues,
- Promoting community awareness of the roles of the mother, including children's and parents' issues in school curricula.
- Forming partnerships and interlinkages among community organizations, caring for juveniles, and outreach to remote areas.

Programs:

- Adopting program criteria, program evaluation and risk assessment, including parenting issues in policies,
- Training personnel in parenting programs,
- Securing funding,
- Issuing manuals for programs on evaluation, and
- Expanding parenting programs.
