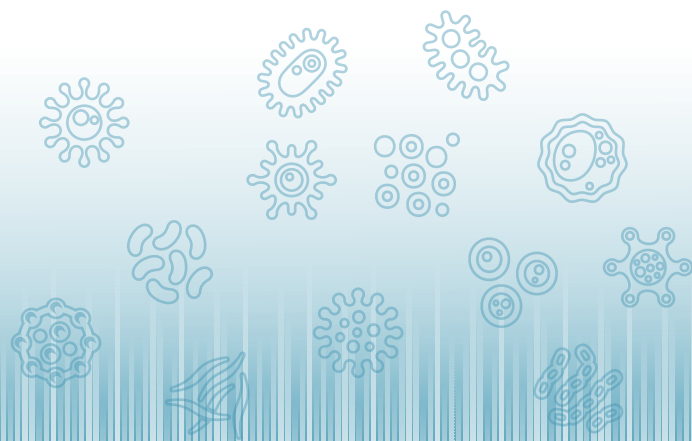

## COMMUNICABLE DISEASES RESEARCH PRIORITIZATION (CDRP)

The CDRP Exercise is planned by the Communicable Disease Control Programs section at the Health Protection and Communicable Disease Division, Public Health Department, Ministry of Public Health Qatar, in collaboration with the Regional Office for the Eastern Mediterranean (EMRO) and the Qatar Country Office of the World Health Organization (WHO), and co-organized by the Doha International Family Institute (DIFI) at Qatar Foundation.

The CDRP activity follows the published WHO guidance on adopting a “systematic approach for undertaking a research priority-setting exercise” and aims to develop a Research Priority List for the designated communicable diseases that is effectively targeting and is tailored to Qatar’s needs and priorities to satisfy the triple aims of better health, better care and better value as high-quality research is a major goal for National Health Strategy 2018 – 2022 and implementing it will encourage innovation and make evidence-based decisions for control programs and strategies
